Thank you for the letter and the information that should have been available openly and transparently with the decision as the documents are referred to in that decision.

I am grateful to Ms Wyss for finally releasing the documents.

I note that Ms Wyss is refusing to give disclosure of the instructions in respect of the Council initiated report obtained from Greenscene, instructions for this report must have been initiated at the end of November early of December 2020 as the report was dated December 2020 and there is correspondence from Greenscene dated 4 and 7 December 2020. No reasons have been given for this refusal. Clearly the document must be available as it was issued at the end of November or beginning of December 2020. There is no reasonable explanation or any explanation at all given for Ms Wyss's continued refusal to produce this document. Please explain the extension of time to 26 February 2021 to produce this document?

My request was made on the 10 January 2021. it is now 10 February your 20 days have passed and you are wanting another 12 days with no explanation? Time is now of the essence. Ms Wyss is requested to produce this document without further delay.
