#### MAY IT PLEASE THE COURT:

 The purpose of this memorandum is to update the Court on further issues that have arisen on Ōwairaka/Te Ahi-kā-a-Rakataura/Mt Albert (Ōwairaka) in relation to damaged exotic trees that have had to be removed.

#### Tree damage from weather events

- 2. In total there have been four recent separate incidents involving tree damage as a result of weather events.
- 3. The first occurred on 30 June 2020 during a bout of heavy rain. This tree was situated on the lower slopes of the north east shoulder below the ring road on the maunga.
- 4. The entire tree was uprooted exposing bare earth. Fortunately, after inspection from staff, there was no apparent archaeological materials in situ or other harm caused.
- 5. A photo of this damaged tree is set out in **Appendix One**.
- 6. The second incident was reported on 6 November 2020 after a storm event. A large olive branch fell onto the road causing a road closure. Branches covering the road were immediately removed. However, a major portion of the branch had to be removed by an arborist at a later date.
- 7. A photo of this damaged tree is set out in **Appendix Two**.
- 8. On 26 November 2020, a large branch fell from a eucalyptus tree situated near the archery field in the vicinity of some of the recent plantings on the maunga. As a result of the branch failure and the removal process, approximately 25 native plants that were planted in the first and second years of planting were destroyed.
- 9. A photo of this damaged tree is set out in **Appendix Three**.
- On 3 December 2020, it was reported that due to a weather event a large branch from a flame tree fell near the north east shoulder of the maunga. Unfortunately, there are no photos of this damaged tree.

#### Health and safety and archaeological concerns

- 11. In each of these incidents, serious injury or loss of life could have been sustained if people were in the vicinity when the branches fell. There could also have been further damage to the archaeological fabric of the maunga.
- 12. These events reinforce the health and safety and archaeological concerns that were raised by the Tūpuna Maunga Authority during these proceedings.
- 13. The Tūpuna Maunga Authority thought it important to bring these events to the attention of the Court.
