Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014

109 Functions and powers

- (1) The Maunga Authority has the powers and functions conferred on it by or under this Act or any other enactment.
- (2) In exercising its powers and carrying out its functions in relation to the maunga, the Maunga Authority must have regard to—
 - (a) the spiritual, ancestral, cultural, customary, and historical significance of the maunga to Ngā Mana Whenua o Tāmaki Makaurau; and
 - (b) section 41(2).
- (3) In exercising its powers and carrying out its functions in relation to the administered lands, the Maunga Authority must have regard to the spiritual, ancestral, cultural, customary, and historical significance of the administered lands to Ngā Mana Whenua o Tāmaki Makaurau.

41 Maunga must remain as reserves vested in trustee

- (1) This section applies to each maunga once the maunga is—
 - (a) vested in the trustee under subpart 1, 2, or 3 of this Part;

and

- (b) declared a reserve under any of sections 18 to 29, 33, and 39.
- (2) The maunga is held by the trustee for the common benefit of Ngā Mana Whenua o Tāmaki Makaurau and the other people of Auckland.

Tūpuna Maunga Annual Operational Plan

Purpose	The purpose of this report is to present the final Tūpuna Maunga Annual Operational Plan 2015/16 (Operational Plan) for approval.		
Recommendations	Staff recommend that the Tūpuna Maunga o Tāmaki Makaurau Authority:		
	(a) note the changes made to the draft Operational Plan;		
	(b) approve the final Operational Plan;		
	(c) note the focus areas for the Operational Plan 2016/17; and		
	(d) note the next steps in relation to the Long-term Plan 2015-2025.		

Background

- 1. The Tūpuna Maunga o Tāmaki Makaurau Authority (**Maunga Authority**) and Auckland Council must agree an Annual Operational Plan (**Operational Plan**) every year under section 60 of the Ngā Mana Whenua o Tāmaki Makaurau Collective Redress Act 2014 (**the Act**).
- 2. The Operational Plan provides a framework in which the Council will carry out its routine management functions for that financial year and sets out what the Maunga Authority can expect in terms of operational deliverables on the Tūpuna Maunga. The Operational Plan 2015/16 has been developed by the Maunga Authority and will be implemented by Auckland Council.
- 3. On 23 April 2015, at the Joint Deliberations meeting, the Maunga Authority and the Governing Body discussed public feedback received on the draft Operational Plan, including that the Tūpuna Maunga represent a significant opportunity for Auckland and that sufficient funding is required to commence the rejuvenation of the maunga.
- 4. At Hui 8 (4 May 2015) the Maunga Authority endorsed the proposed 10 year budget in the draft Operational Plan 2015/16 and draft Long-term Plan 2015-25.
- 5. The key programmes outlined in the Operational Plan include:
 - a. a capital and renewal program with a focus on protecting sites of significance and landscape protection;
 - b. developing an innovative Integrated Management Plan (IMP) that will set a vision for the future of these important taonga; and
 - c. community engagement and education through completing signage upgrades, kiosk information centre and website design.
- 6. Future Operational Plans will ensure implementation of the IMP's high level strategy at a tangible operational level.

Changes made to the draft Operational Plan

- 7. At Hui 3 (3 November 2014) the Maunga Authority endorsed the draft Operational Plan.
- 8. The majority of changes made to the draft version endorsed at Hui 3 have been around formatting, typographical errors, and ensuring decisions and timeframes are as up to date as possible. The version we are seeking your agreement to also incorporates feedback from the public consultation process that occurred in the context of the draft Long-term Plan 2015-25 (but is otherwise consistent with the version approved at Hui 3).
- 9. The substantive changes are captured in the table below.

Focus areas for the future Operational Plan 2016/17

- 10. Officers will commence work on the Operational Plan 2016/17 in August 2015. Key focus areas are likely to be:
 - a. ensuring the statutory purpose of the Maunga Authority, Tūpuna Maunga Values, management principles and the strategic vision captured in the IMP are meaningfully translated into operational decisions, and the connection between the strategy/vision and operational decisions is evident;
 - b. fulsomely addressing the matters referred to in section 60 subsection 4 of the Act, including but not limited to facilitation of authorised cultural activities, educational programmes, and Ngā Mana Whenua o Tāmaki Makaurau programmes including iwi or hapū programmes and opportunities for members of Ngā Mana Whenua o Tamaki Makaurau to carry out or participate in any of the activities described in this section (i.e. strategic, policy and planning projects, and maintenance and operational projects); and
 - c. refining the quality and relevance of information contained in the document.
- 11. A further focus area could involve ensuring that information can be easily used by visitors to the Tūpuna Maunga, providing greater detail around budget expenditure and capital projects, ensuring information regarding assets on the maunga is relevant and easy to understand, and outlining tangible deliverables for the various categories, for example leases and partnerships.

Next steps in the Long-term Plan 2015-25 process

12. The Operational Plan aligns with the Long-term Plan 2015-2025 (**LTP**). On 7 May 2015 the Governing Body made final decisions on a budget of \$45,671,879 capital funding and \$30,733,031 operating funding over 10 years for the Maunga Authority.

13. The next steps are:

- a. 8 June 2015 the Maunga Authority approves the final Operational Plan with the budget set by the LTP; and
- b. 25 June 2015 the Governing Body adopts the LTP with a summary of the final Operational Plan.

Tūpuna Maunga Weed Control Programme 2015/16

Purpose	The purpose of this report is to seek approval from the Tūpuna Maunga o Tāmaki Makaurau Authority (Maunga Authority) to undertake the proposed Tūpuna Maunga Weed Control Programme 2015/16.		
Recommendations	Staff recommend that the Tūpuna Maunga o Tāmaki Makaurau Authority:		
	(a) approve the Tūpuna Maunga Weed Control Programme 2015/16, including:		
	 the proposed budget allocation of \$250,000; 		
	ii. the use of biological controls for certain weeds; and		
	iii. the proposed procurement plan.		

Background

1. At Hui 1 (15 September 2015) the Tūpuna Maunga o Tāmaki Makaurau Authority (Maunga Authority) adopted the standard operating procedures and delegation manual. The manual requires the Maunga Authority to approve an annual weed programme. Auckland Council is responsible for the programme implementation, appointment of contractors, and compliance with relevant health and safety requirements.

Weed Control Programme 2014/15

Engagement with Ngā Mana Whenua o Tamaki Makaurau

- 2. In early 2014 Council officers consulted with the Tāmaki Collective regarding weed eradication priorities and control methods on the Tūpuna Maunga. This led to the development of a weed control programme incorporating Mana Whenua world views.
- 3. The 2014/15 Programme and methods were, as a result, strongly focused on protection and restoration of biodiversity, as well as a desire to limit agrichemical use on the Tūpuna Maunga.

Outcomes of the 2014/15 Programme

- 4. The 2014/15 Weed Control Programme has now been successfully completed on eleven of the Tūpuna Maunga. The total cost of implementing the Programme was \$155,000.
- 5. The Programme's key outcomes were that it:
 - a. resulted in an 80% reduction of herbicide in comparison to standard weed control methods;
 - b. targeted 56 weed species across the Tūpuna Maunga;
 - c. delivered 73 person hours of control per maunga; and
 - d. used an average of 1.5 litres of herbicide concentrate per maunga.
- 6. Three of the Tūpuna Maunga did not receive any control over this period:

- a. Takarunga / Mt Victoria, which has a no-spray policy in place under its current management plan;
- b. Matukutūruru / Wiri Mountain, which has recently been surveyed and is included in the 2015/16 Programme; and
- c. Rarotonga / Mt Smart, which has been surveyed and is to have a targeted programme developed.

Proposed Weed Control Programme 2015/16

7. The 2015/16 Programme will continue to prioritise the treatment of weeds identified as requiring urgent attention. Please see **Attachment A** for weed control priorities, recommended methods, and a budget breakdown specific to each maunga.

Budget allocation

- 8. Officers recommend a budget of \$250,000 for the 2015/16 Programme. The increase from 2014/15 reflects the additional funding obtained in the Long-term Plan 2015-2025.
- 9. The budget increase will be distributed across the Tūpuna Maunga that are already subject to weed control. In addition, weed control will be carried out on Takarunga / Mt Victoria, Matukutūruru / Wiri Mountain, and Rarotonga / Mt Smart. Attachment A shows the proposed budget breakdown across the Tūpuna maunga.
- 10. The proposed increase also allows the 2015/16 Programme to include medium priority weed species, as well as weed species located on sensitive and culturally significant sites such as tihi, pits, and terraces.

Biological controls

- 11. Officers recommend the use of biological controls as an option to manage certain weeds on the Tūpuna Maunga. Biological controls involve the release of insects or fungi that naturally prey on introduced pest plants. Approved releases are rigorously tested by Landcare Research for a minimum of five to ten years to ensure they do not adversely affect any native or primary production species.
- 12. Biological controls work well in targeting very large weed infestations that would take a long time to control using other methods. Species on Ōtāhuhu, such as tradescantia and ragwort, have been identified as viable weeds for targeting. Biological controls do not involve the use of herbicides, which Mana Whenua are eager to avoid.

Procurement plan

- 13. Officers propose that, in the absence of a Maunga Authority procurement policy, the procurement process for the appointment of contractors mirrors the Auckland Council procurement process. The procurement process will be a publicly advertised request for proposal for weed control services, with responses evaluated using the weighting attributes method.
- 14. The selected service provider will be contracted for a term of three years and reviewed annually against performance. The three year term will enable the successful candidate to invest in their business, staff, and capacity and capability. It will also ensure continuity of service, both in terms of the client-contract relationship and the methodology applied.

Recommendations

- 15. Officers recommend the Maunga Authority approves the proposed Weed Control Programme 2015/16, including:
 - a. the proposed budget allocation of \$250,000;
 - b. the use of biological controls for certain weeds; and
 - c. the proposed procurement plan.

Background

1. At Hui 4 (1 December 2014) the Tūpuna Maunga o Tāmaki Makaurau Authority agreed that a register of Health and Safety incidents identified in respect of the Tūpuna Maunga should be created and updated for each subsequent Hui for noting.

Summary

- 2. Attachment A is the latest Health and Safety Register (which includes earlier summaries of Health and Safety incidents).
- 3. Only two Health and Safety incidents were reported in respect of the Tūpuna Maunga for the period since Hui 8 (4 May 2015), both at Maungawhau.
- 4. Of the two incidents reported, one was a near miss relating to vehicles ignoring the stop sign at the exit to Puhi Huia Road at Maungawhau. Officers are aware of this issue as it has already been reported by the Tāmaki Hīkoi guides. We will install two speed bumps at appropriate locations and continue to monitor the situation.

Ensuring the Tūpuna Maunga are healthy and safe places

5. It is important to think proactively about what we can do to make the Tūpuna Maunga healthy and safe places. Officers are starting to build a picture of the general nature of the health and safety issues that occur on the Tūpuna Maunga and will report back at Hui 10 (6 July 2015) with further advice on this topic.

Media coverage April

Media coverage has been very light this month.

Devonport Flagstaff

The Devonport Flagstaff has been the most active media outlet – they are committed to publishing any news about the Devonport maunga. Their May articles are attached below. They are continuing to quote Mike George as a Maunga Authority spokesperson despite clear instruction to attribute comments to the Chair or Scott De Silva, so some relationship work needs to be done there. David Seymour (ACT Party) LGOIMA

David Seymour's office submitted a LGOIMA request asking for the reports received by the Maunga Authority indicating damage caused to the tihi of Maungawhau by private vehicles. A response from Justine Smith (through the Chair) was issued on 21 May. ACT has not issued any public communication about this – but they may do.

NZ Herald enquiry about filming and events fees and permits

Wayne Thompson from the NZ Herald enquired about filming and events fees and permits on the Maunga. A response from Scott De Silva was provided 27 May.

1 May - Mountain bikes back on Mt Vic (Devonport Flagstaff)

Mountain bikes back on Mt Vic

Mountain biking is back on Mt Victoria – for the time being.

A sign banning off-road biking on the summit of Mt Victoria is gone.

Auckland Council Volcanic Cones Manager Scott De Silva says the sign was originally installed after council received a number of public complaints about off-road mountain bikers.

Maunga Authority spokesperson Mike George told the Flagstaff at the time that the authority did not need to consult the public on the ban as preventing damage was a routine

management issue.

But this month council, who co-manages the mountain with the authority, changed tack. "After further consideration, it was felt that decisions relating to off-track mountain biking should be addressed through the integrated management plan process, which is due to start this year. The sign was subsequently removed," De Silva said.

North Shore Ward Councillor Chris Darby told the Flagstaff: "Things have been sorted for now."

He said public feedback will be a crucial part

of shaping the management plan and that council staff were keeping an eye on the graveyard area where some damage caused by bikes has been reported.

De Silva said that "protection and conversation of the maunga are high priorities for the Maunga Authority who co-manages the cones with council.

"Visitors are encouraged to consider the importance of protecting this taonga and to help minimise the impact of recreational activities on the maunga," he said.

1 May - Ride-on mower goes walkabout (Devonport Flagstaff) Ride-on mower goes walkabout

A large ride-on mower tumbled down the northern side of Mt Victoria last Thursday morning without injuring its driver or morning walkers.

According to the mowing contractor, a member of staff had just finished his run on top of the cone parked the mower without wrecked mower securing the handbrake.
